



DIRECTORY OF LEAD-SAFE STAKEHOLDER ORGANIZATIONS IN DETROIT



The Directory of Lead-Safe Stakeholders in Detroit is a tool for understanding the activities and partnerships of stakeholder organizations working to end child lead poisoning in the city. The Directory also includes stakeholders whose activities do not expressly center on ending child lead poisoning but enable other stakeholders to carry out this work.

The Directory is not an exhaustive list of all stakeholders that may affect child lead poisoning. Preventing child lead poisoning is an issue that requires the involvement of many different organizations and groups across all sectors. Landlords, private businesses, non-public schools, and other stakeholders not listed here have a role to play in preventing and ending child lead poisoning.

The Directory is a collaborative project between the City of Detroit Housing & Revitalization Department and Poverty Solutions at the University of Michigan. The Directory was originally completed by Leonymae Aumentado and Kate Brantley at Poverty Solutions at the University of Michigan based on interviews with organizations and public information made available on organization websites between July 2021 and April 2022, and will be updated approximately every six months. 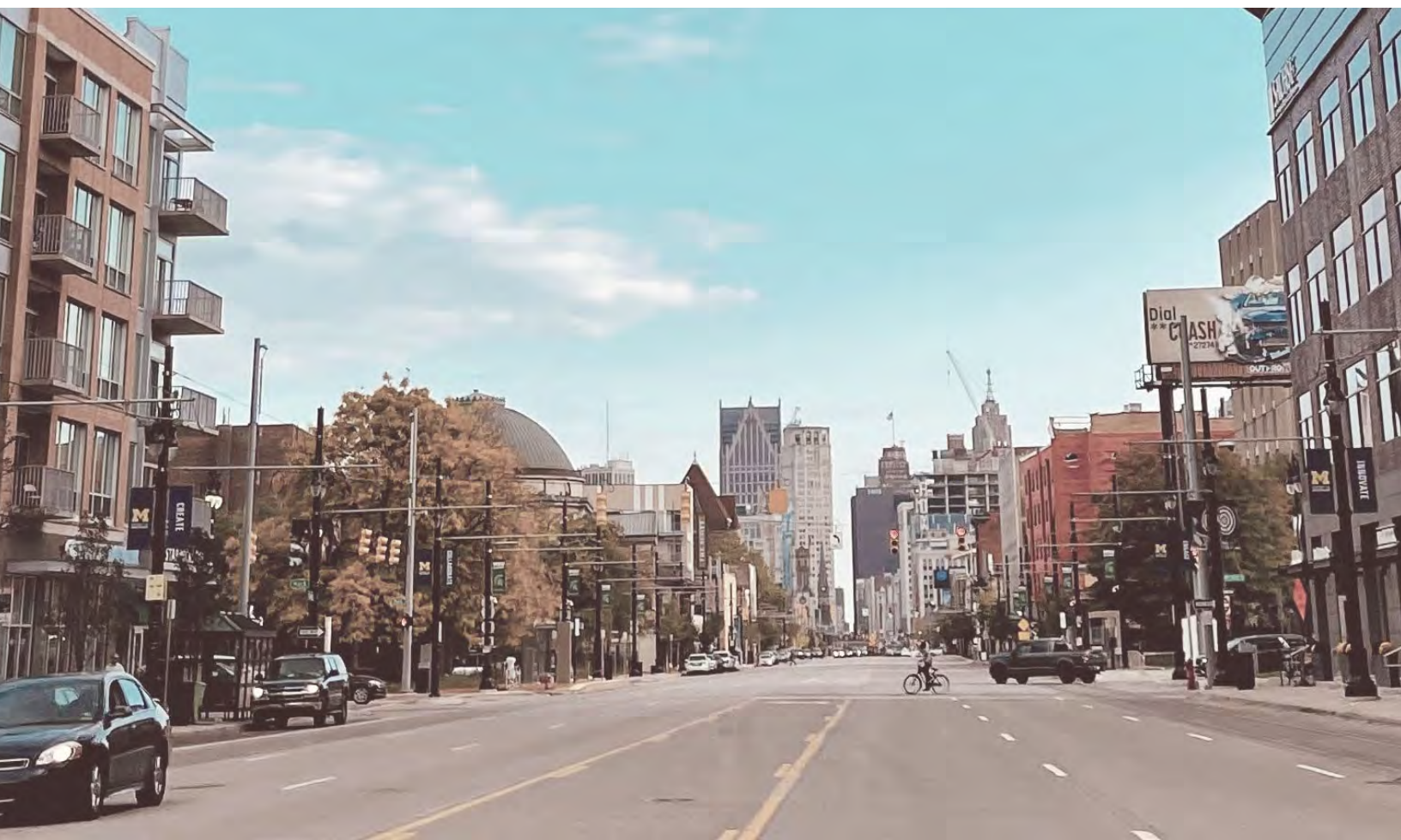
